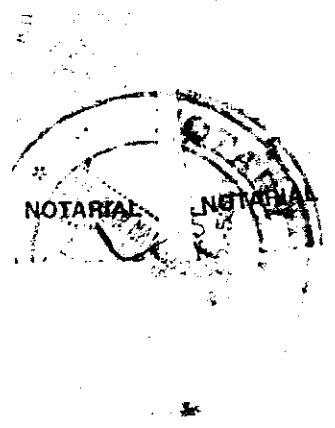

These regulations unless the institution or society sponsoring the institution is in possession of required land on the date of application. 
